*The Housing Authority of the City of Milwaukee*, Milwaukee, Wisconsin, will receive quotes for furnishing all labor, materials, equipment, and services for performing all work necessary and incidental for **Challenge Grant/Milwaukee Home Program Residential Rehabilitation at 3374/3376 North 2<sup>nd</sup> Street** until **4:30 PM (CDST) on Friday, April 22, 2016**, at the Modernization & Development Services office of the Housing Authority located at 5125 West Lisbon Avenue, Milwaukee, Wisconsin 53210. Quotes may be mailed/delivered to the office or faxed to the office at (414) 286-8742.

**A pre-bid inspection of the interior and exterior of the site is scheduled for Tuesday, April 5, 2016 at 9:15 AM.** The site may also be inspected by appointment only up to one week prior to the bid due date (i.e. until Friday, April 15, 2016). However, it is highly recommended that prospective bidders attend the scheduled inspection on Tuesday, April 5, 2016 as there are limited times available for subsequent site inspection appointments and no guarantee that requests for appointments can be accommodated. **A pre-bid inspection of the interior and exterior of the site is mandatory in order to submit a quote.**

**BID INSTRUCTIONS/CONDITIONS**

Bidder shall complete the Pricing section (below) of this Summary and Quote Form. Quotes shall be for a lump sum. However, bidders may be asked to subsequently provide a schedule of values or other breakdown. Quotes shall be in accordance with the Bid Documents and Projected Timeline as enumerated above.

Bidder shall indicate if it is a certified Small Business Enterprise (SBE) as defined in Chapter 370 of the Milwaukee Code of Ordinances and as administered by the Office of Small Business Development of the City of Milwaukee.

Bidder shall attach a list of all proposed subcontractors and their respective trades or roles. Bidder shall identify any proposed subcontractors that are certified SBEs, indicating what dollar amount or percentage of the total lump sum bid is attributable to each proposed SBE subcontractor.

Bidder shall provide five references of past construction projects. For each reference, Bidder shall indicate the client or owner, the scope of services, the dollar value of the project, and the date of project completion. For each client or owner, Bidder shall provide address, contact person, telephone number, and e-mail address.

Bids from prospective contractors that did not send a representative to the pre-bid inspection (or make other arrangements to inspect the interior and exterior of the site before bids are due) will be rejected.
